Face to face teaching-

Face-to-face teaching has several advantages, including the ability to build strong teacher-student relationships, enhance non-verbal communication skills improve their personality, behavior and value system and create a structured learning environment where Teachers gain to feedback of students. learning is accessible, with a choice of recordings and animated animations that simply and engagingly convey a variety of subjects.

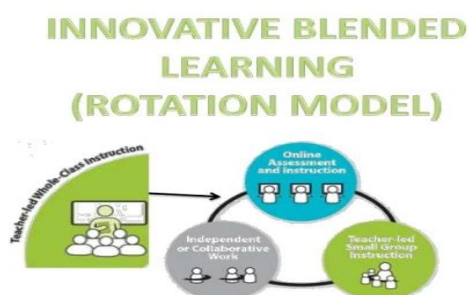
Blended Learning Models

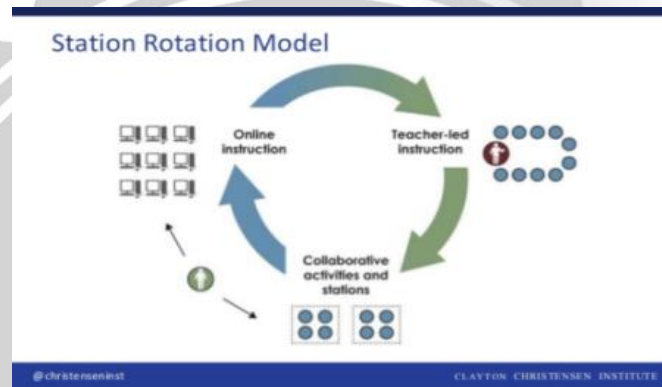
Rotation Model

There are variations of this model, including the Station Rotation model and the Lab Rotation model, which emphasize different types of activities during the rotations. The Blended Learning Rotation Model is a type of instructional approach that combines both traditional classroom teaching and online learning. It is a form of blended learning where students rotate between different learning modalities or stations. (Govindaraj & Silverajah 2017)



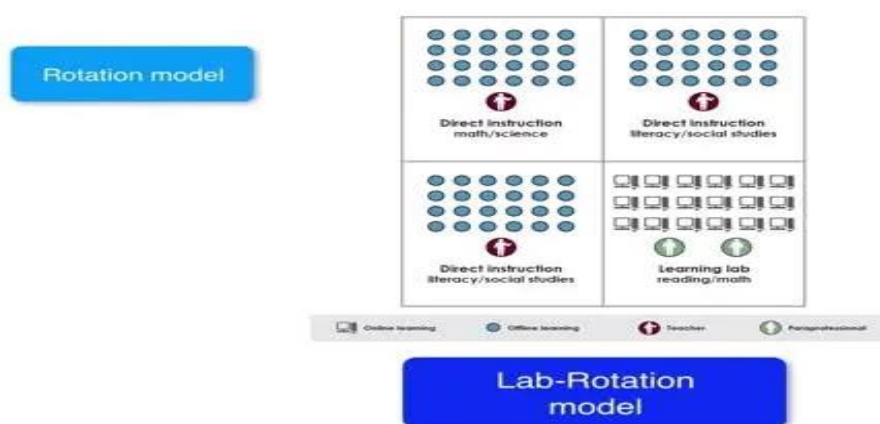
Station Rotation Model

Students spend a designated amount of time at each station before rotating to the next one. 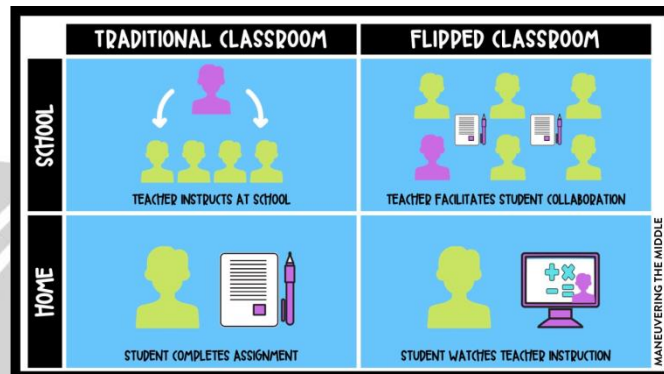
Lab Rotation Model

For example, students might spend part of their day in a classroom with the teacher for direct instruction and then move to a computer lab for online activities, simulations, or exercises. The online component can be used for personalized learning, assessment, and practice. The lab rotation model involves rotating between a classroom and a learning lab for online learning. (Staker & Horn, 2012).



Flipped Classroom Model

While not exactly the same as a rotation model, the flipped classroom is also a form of blended learning where students learn content online at home through videos or other resources, and then engage in active learning and discussion during in-person class time. The Flipped Classroom model, on the other hand, involves rotating between face-to-face teacher-guided practice (or projects) at school and online content and instruction at home or off-site (Staker & Horn, 2012).



Flex Model

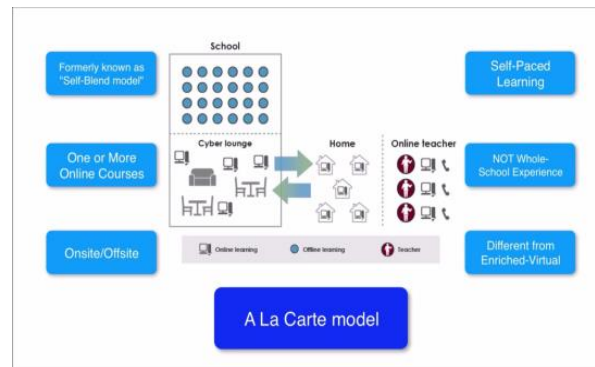

A La Carte Model

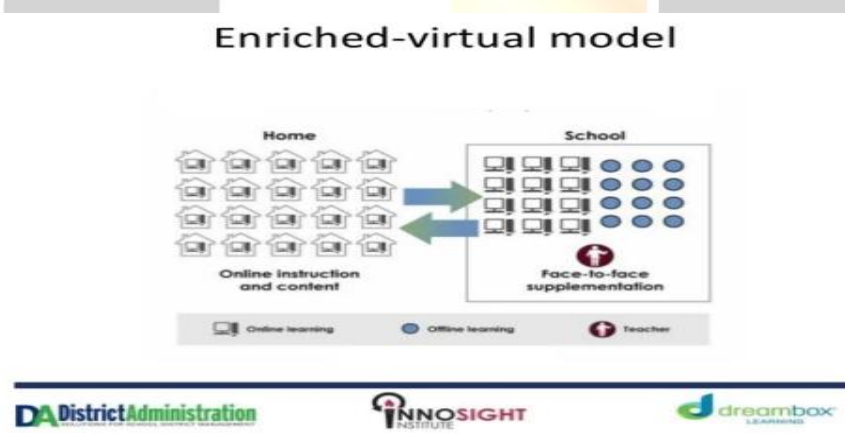

Enriched Virtual Model

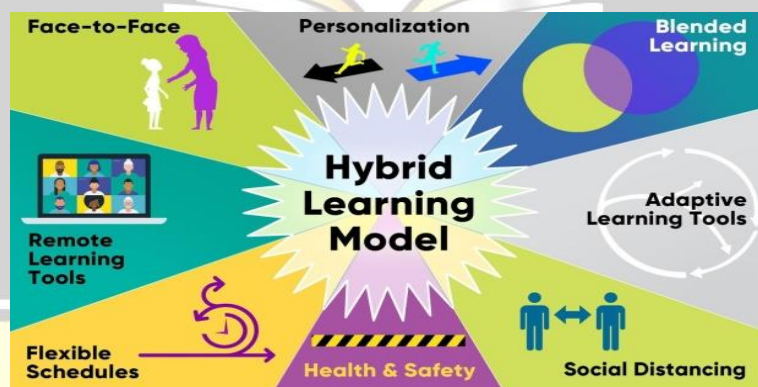
Flipped Classroom Model

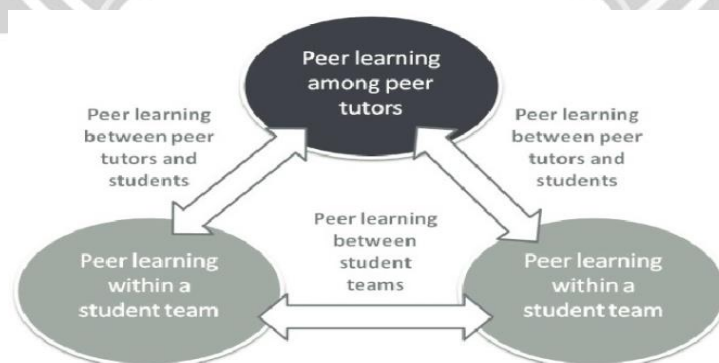


Hybrid Model
