- ❖ All independent teacher education institutions must become multidisciplinary institutions by 2030 and obtain the minimum qualification for school teachers.
- ❖ The proposed four years integrated B.Ed. program offers a unique combination.
- ❖ A bachelor's degree in education with expertise in a specific subject such as science, arts, humanities, language, or music.
- ❖ It goes beyond mere pedagogy and immerses future teachers in vital domains such as philosophy, psychology, sociology, and Indian history and culture. In addition, they acquire fundamental literacy and numeracy, preparing them to effectively nurture young minds.
- ❖ This initiative aims to raise a generation of teachers who are not only proficient in modern teaching methods but also deeply rooted in the wisdom and ideals that define the cultural landscape of India.
- ❖ Institutions that offer four years integrated B.Ed. programs may also offer two years B.Ed. programs to those who have a bachelor's degree in the core subjects.
